## What are Cookies?

Cookies are small pieces of text stored on your computer's hard disk when you visit a website. They are not programs and cannot be executed as code, deliver viruses or install malware.

These cookies monitor the way users navigate around our website, allowing us to improve our site content and provide you with a better user experience. We can use this data to tailor the site to individual preferences and help users find the information they need more easily.
